June 9, 2021

The City Council of Essex met June 9, 2021 at 7:00 PM in the Community Room, Essex City Hall. Mayor Durfey called the meeting to order and roll call was taken showing the following members of the Council present or absent. Present: Correll, Gay, Kinney, Wenstrand. Absent: Franks.
