REGULAR SESSION

April 12, 2023

The Essex City Council met in regular session at the Essex Community Room at 7:00 PM. Mayor Kinney called the meeting to order and roll call was taken showing the following members of the Council present or absent. Present: Ballinger, Eshelman, Franks, Thornton, Wenstrand. Absent: none. City Attorney Sorensen and City Clerk Ohnmacht were also present.

The Agenda was approved. Motion by Franks, second by Wenstrand. Ayes: All.

Guests present: Diane Liljedahl, Brian Steinkuehler, Heidi Hertensen, Lori Johnson, Dennis Gresham, Lyl Ellis, Tracey Ellis, Becki Franks, Tara Sample, Beau Sample, Jeremy Schmidt, and Patty Perry.

Public Comments: Lyl Ellis spoke in favor of urban chickens. Lori Racine requested trash cans in park be fastened down. She also spoke against urban chickens. Lori Johnson spoke against urban chickens.

Brian Steinkuehler informed the Council how liability insurance should be requested from potential renters of the Opera House. He also explained how the sale of alcohol would need to work.

Council updates: Ballinger discussed planting of flower pots. Eshelman reported state level discussion on urban chickens. Mayor Kinney reported that generator project at the school should be complete by June 1st. There are 14 meters left to be replaced. Updated the Council that water tower project needed to be completed by May 2027 to secure the low interest funding the City has qualified for.
