December 13, 2023

The Essex City Council met in regular session at the Essex Community Room at 7:00 PM. Mayor Kinney called the meeting to order and roll call was taken showing the following members of the Council present or absent. Present: Ballinger, Franks, Thornton, Wenstrand. Absent: Eshelman. City Clerk Ohnmacht was also present. City Attorney Sorensen entered the meeting at 7:16 PM.

And Ordinance 2023 – 7 An Ordinance Granting to MidAmerican Energy Company, It's Successors and Assigns, the Right and Non-Exclusive Franchise to Acquire, Construct, Erect, Maintain and Operate in the City of Essex, Iowa, An Electric System And Communications Facilities and to Furnish and Sell Natural Gas to the City and Its Inhabitants and Authorizing the City to Collect Franchise Fees for a Period of 25 Years.
