REGULAR SESSION May 14, 2025

The Essex City Council met in regular session in the Essex Community Room at 7:00 PM. Mayor Kinney called the meeting to order and roll call was taken showing the following members of the Council present or absent. Present: Ballinger, Eshelman, Franks, Gresham, Wenstrand-Larson. Absent: none. Former City Clerk Ohnmacht, new City Clerk Catherine Moore and City Attorney Sorensen were also present.
