Jeff agreed he could help this year as he has more availability than in the past. Moore said she talked to camera guys and camera can be moved up with a lift and have a better view of the entire pile, Jeff said he can help with getting a lift. Council would like to start charging tree trimming service to dump trees, it has become an issue of them dumping a lot and they are very large trees. They also want them to sign a waiver when doing work for the city if they damage anything (sidewalks, etc), they are responsible for repairs. Calvin thanked everyone for their support and his reelection and said going forward he wants to hold employees and council to a higher standard. He also invited Kevin to sit in on budget meetings coming up to help him to see how the process works. At 8:01pm council member Franks had to leave the meeting.
